III. Presentations

P1.

Sandy Newby, TRWD Chief Financial Officer, and Travis James, TXP Vice President, provided TXP's updated forecast of Trinity River Vision Tax Increment Financing District 9 (TIF9). The supporting study document will be forwarded to the Directors.

P2.

Kate Beck, TRWD Program Director, provided a local sponsor update on the North and South Bypass Channel projects to include the gates and pumps design contract, the Ham Branch

Aquatic Mitigation design, the University Drive design contract, the design of the two pedestrian bridges, the completion of demolition packages #1 and #2, and the demolition contract for the final buildings. TRWD, City of Fort Worth, and USACE leadership have begun meeting with TxDOT leadership to ensure proper coordination. Ms. Beck concluded with a review of the Central City budget and a briefing on reallocation of Local Share of the Central City budget. President Maenius requested that consideration for approval of the Local Share budget be made an action item for the next TRVA Board of Directors meeting.

P3.

Dana Burghdoff, City of Fort Worth, Assistant City Manager, provided an update of City projects to include the Grand Ave Stormwater Project, Part 14 Sanitary Sewer Project, Greenleaf Stormwater Sump Project, Viola Stormwater Project, and the North University Dr. Project. Ms. Burghdoff noted that once construction begins, University Dr. would be closed for up to 18 months.

P4.

Dana Burghdoff, City of Fort Worth, Assistant City Manager, and Kate Beck, TRWD Program Director, provided an update on Panther Island Development. City, TRWD, Tarrant County, Tarrant County College District and three other agencies have come together to work on the update of the 2004 Trinity Uptown Plan and associated documents. HR&A has provided the Steering Committee with the Strategic Vision and Real-estate document as well as the Economic Development and Implementation document. The Steering Committee's comments are being integrated and the documents should be released in early March.
