Kelly Wood, TRWD Program Manager, provided a local sponsor update on the North and South Bypass Channel projects to include the flood gate and pump station design contract, the University Drive project, and the Ham Branch aquatic mitigation project. He also discussed the Industry Day hosted by the U.S. Army Corps of Engineers as well as provided updates on the demolition of the Mechanic Shop and subsequent environmental remediation.

Dana Burghdoff, City of Fort Worth, Assistant City Manager, provided an update of City projects starting with the City's utility relocations on the North and South Bypass Channels, to include the Grand Ave Stormwater Project, Part 10 waterline, Part 14 Sanitary Sewer Project, Greenleaf Stormwater Sump Project, Viola Stormwater Project, and the North University Dr. Project.

Dana Burghdoff, City of Fort Worth, Assistant City Manager, provided an update on Panther Island Development. She noted that the Fort Worth City Council and the TRWD Board of Directors were briefed on March 5, 2024, with the final reports from HR&A and Lake Flato.
