MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF TRINITY RIVER VISION AUTHORITY ("TRVA") HELD ON THE 8th DAY OF JULY, 2020 AT 2:00 PM

The call of the roll disclosed the presence of the Directors as follows:

Directors Maenius, Cooke, Riley, Hill, Flores and Brooks appeared via videoconference. Also in attendance via videoconference were: Sandy Newby, Woody Frossard, Mick Maguire, Debra Witherspoon, Mark Mazzanti and Marty Leonard of the Tarrant Regional Water District ("TRWD"); Doug Rademaker and Kate Beck of the City of Fort Worth ("COFW"); and Lee Christie and Ethel Steele of Pope, Hardwicke, Christie, Schell, Kelly & Taplett, L.L.P.

I. Call to Order

President Maenius convened the meeting at 2:01 P.M. with the assurance that a quorum was present and all requirements of the Texas Open Meetings Act had been met.

II. Public Comment

No public comment.

III. Presentation(s)

On behalf of the City of Fort Worth (COFW), Doug Rademaker, P.E. (COFW, Bridge Project Manager) presented an update on the City of Fort Worth bridge construction. Mr. Rademaker reported that construction continues on the bridges. He advised that the White Settlement Bridge steel has been placed on the span infill areas for abutment 1, bent 2/3, bent 3/4, bent 4/5, and abutment 6; the cantilever false work for bents 2, 3 & 4 are constructed; the infill bottom slabs for abutment 1/bent 2, bent 2/3 and bent 4/5 and the infill webs for bent 2/3 and bent 3/4 are poured; and the Panther Island Red sidewalk pavers are installed on the Commercial and White Settlement roundabout approaches. He also showed the Board panoramic photographs of the bridge cantilever false work, the top deck construction, diagrams of the box girder system progress, photographs of the installed Panther Island Red sidewalk pavers near the bridge approach, and the gray contrast brick at the sidewalk approaches. He advised the Board that the stacked stone cap wall is completed in the White Settlement roundabout. Next, Mr. Rademaker reported on the Henderson Street Bridge construction progress, noting that the tie beams are installed on bents 4 & 5, the tie beam end blocks are poured on bents 4 & 5, the bent 2 diaphragm leave-outs are poured, and the V-pier superstructure is stressed and grouted. He also showed the Board photographs of each portion of the Henderson Street Bridge construction progress. Last, Mr. Rademaker reported on the construction progress on the North Main Street Bridge. He advised the Board that the transverse post tensioning is complete, bents 2 & 3 are now free-standing, the steel has been placed on the span infill area at abutment 1/bent 2, and the cantilever false work is constructed on bent 3. He also showed the Board photographs of each portion of the North Main Street Bridge construction progress.

IV. Action Items

On a motion made by Director Riley and seconded by Director Brooks, the Directors voted to approve the minutes of the meeting held on June 3, 2020.

With the recommendation of Sandy Newby (TRWD, Chief Financial Officer), Director Cooke made a motion to receive and file the Central City Finance Report of May 31, 2020. The motion was seconded by Director Flores and the vote in favor was unanimous. The Central City Finance Report of May 31, 2020 and Budget Approach are attached hereto as Exhibit "A".

With the recommendation of Mark Mazzanti, (TRVA, Flood Control Risk Management Coordinator), Director Brooks made a motion to receive and file the Central City Flood Project Risk Management Report. The motion was seconded by Director Cooke and the vote in favor was unanimous. The Central City Flood Project Risk Management Report is attached hereto as <u>Exhibit</u> <u>"B".</u>

Trinity River Vision Authority Board Meeting, Wednesday, July 8, 2020 Mazzanti Remarks

- no major items to report since last month
- several items to update, including current status and future challenges
- the project has been proceeding, though at a reduced level of execution, with the intent to maintain Corps' eligibility to request annual funding. All activities are progressing well and have remained on schedule.

TRWD STATUS OF ACTIVITIES (ENVIRONMENTAL/DEMOLITION) - 4 Environmental Demolition projects are proceeding well, with a little over \$3m to be spent this year but another \$3m would be needed next year to complete all environmental work - Projects are – Police and Fire, Rubin, Radio Shack, Star R Foam

However, the demolition projects must complete to allow environmental remediation to take place. Properties with environmental remediation must ultimately be accepted by TCEQ as part of the VCP - Voluntary Cleanup Program, which means completing the remediation according to TCEQ requirements.

COFW STATUS OF ACTIVITIES - City of Fort Worth utility relocations (water, sewer and stormwater) need to finish before USACE can finish design of the North and South Bypass Channel. Many of these utilities are in the design phase and therefore need to be completed in order for the Corps to continue to request federal funds

Franchise utilities are already in the process of design and procurement of major crossings associated with both North and South Bypass Channel. If the City does not continue to support the franchise utilities (Oncor, AT&T, Atmos) according to the franchise utility agreements, the time required to re-start projects will significantly increase current schedules and cost.
